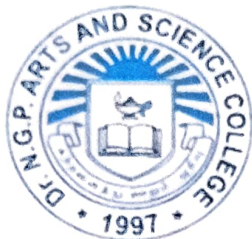

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter it's called as "MOU") is made on **Tuesday 31st December 2024 at Coimbatore, Tamil Nadu, India.**

By and Between

The **Dr. N.G.P Arts and Science College (Dr. N.G.P. ASC)**, Dr. N.G.P. Nagar, Kalapatti Road, Coimbatore-642109, represented by its Principal Dr. S. Saravanan (hereinafter referred to as "**First Party**", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

and

The **Agaram Biotech, Devampalayam, Avinashi TK, Tirupur – 641 654, Tamil Nadu, India**, represented by its Managing Director Mr. Praveen Ramachandran (hereinafter referred to as "**Second Party**", Coimbatore based concern).

First Party and second party shall be hereinafter collectively referred to as "**Parties**" and individually as a "**Party**".

The first party, i.e., Dr. N.G.P. Arts and Science College (Dr. N.G.P. ASC) is an organization of Dr NGP Research and Educational Trust, Coimbatore (Dr. NGPRET), which was established in the year 1997. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-Accredited by NAAC with "A⁺⁺" Grade (3rd Cycle).

The second party, i.e., The Agaram Biotech, is an organization of which was established in the year 2023.

WHEREAS:

- A.** The **Agaram Biotech**, for Professional Education has agreed to assist Dr. N.G.P. ASC with respect to use of its institute to provide support to B. Sc. and M. Sc. Microbiology Programmes conducted by Dr. N.G.P. ASC.
- B.** Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering support at the **Agaram Biotech**, on terms and conditions as set out in this Agreement.

NOW, THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. SCOPE OF THIS AGREEMENT

- 1.1** To provide students of B. Sc., and M. Sc., Microbiology programs conducted by Dr. N.G.P. ASC on internship training for a period of 15-30 days, at Agaram Biotech, Tirupur.
- 1.2** To train students on the production and marketing of biofertilizers developed at Agaram Biotech, Tirupur.
- 1.3** To share expertise of the second party in the form of Guest Lectures, Workshops, and Training programmes.
- 1.4.** The first party will intellectually support the second party and help them in enhancing their products.
- 1.5.** To provide project training for the students of first party at the venue of the second party.

2. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:

2.1 TERM:

This Agreement shall be valid for a period of Three (3) years from the date of last signature by the Parties ("Term"), unless terminated earlier by the Parties as provided hereinafter. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.

2.2 TERMINATION:

The Dr. N.G.P. ASC and Agaram Biotech, shall be entitled to terminate this Agreement by providing a written notice of two months to other, without assigning any reasons whatsoever.

3. STUDENTS SAFETY:

The Dr. N.G.P. ASC shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the Agaram Biotech. The students shall strictly adhere to all the policies laid down by Agaram Biotech.

4. REPRESENTATIONS AND WARRANTIES OF THE Dr. N.G.P. ASC:

- 4.1 The Dr. N.G.P. ASC shall ensure that its students follow all rules and regulation of the Agaram Biotech, pertaining to leave, discipline, Practical classes, Training and project work schedule, grooming and etiquettes etc. More than two incidents of indiscipline/ non-cooperation will lead to intimation by Agaram Biotech, to Dr. N.G.P. ASC for the termination of Internship, Training and project work period of any students without any notice or prior information.
- 4.2 The Dr. N.G.P. ASC shall ensure that the students to adhere to the attendance requirements as decided by Agaram Biotech, and Dr. N.G.P. ASC during the Internship, Training and project work period

5. MISCELLANEOUS:

- 5.1 **Severability:** Each and every obligation under this Agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.
- 5.2 **Counterparts:** This Agreement shall be executed in two counterparts, all of which shall constitute one and the same agreement.
