MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (here after it's called as MoU) is made on Wednesday 08.02.2023 at Coimbatore, Tamil Nadu, India.

By and Between

The **Dr. N.G.P Arts and Science College** (Dr. NGPASC), Dr.N.G.P. Nagar, Kalapatti Road, Coimbatore-642109, represented by its Principal **Prof.Dr.V.Rajendran** (here in after referred to as **First Party**, the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

And

The **Moon Foods**, No.155/10, Kollapatti, Animoor PO, Kokkaraiyanpettai Main Road, Tiruchengode-637214, Namakkal Dt. Tamil Nadu, represented by its CEO, **Dr. P Sathiya Moorthi** (here in after referred to as **Second Party**, Coimbatore based concern Auto-OEM Industries).

First Party and second party shall be here in after collectively referred to as **Parties** and individually as a **Party**.

The first party, i.e., **Dr. N.G.P. Arts and Science College (Dr.N.G.P.ASC)** is an organization of KMCRET trust which was established in the year 1997. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-accredited by NAAC with A⁺⁺ Grade (3rd Cycle - 3.64 CGPA).

The second party, i.e., **The Moon Foods** is an organization of manufactures of value added millet products was established in the year 2009.

WHEREAS

- A.** Moon Foods has agreed to assist Dr.N.G.P.ASC with respect to use of its institute to provide support to B.Sc.Food Science and Nutrition and M.Sc. Food and Nutrition conducted by Dr.N.G.P.ASC.
- B.** Towards this, the Parties hereby agree to enter into this agreement to record their understanding in offering support at the Moon Foods on terms and conditions as set out in this agreement.

NOW, THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERE TO AS FOLLOWS


1. SCOPE OF THIS AGREEMENT

- 1.1** To conduct regular theory (10 to 15%) and practical classes (90 to 85%) at Dr.N.G.P.ASC for the students admitted under B.Sc. Food Science and Nutrition and M.Sc. Food and Nutrition program at Dr.N.G.P.ASC.
- 1.2** To organize workshops / Seminars / Hands-on-training for the benefit of Dr.N.G.P.ASC staff and students.
- 1.3** Dr.N.G.P.ASC agreed to pay Rs.1000/- (Including GST) participant in favour of Dr. P Sathiya Moorthi, through cheque in advance.

2. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION

2.1 TERM

This agreement shall be valid for a period of One (1) year from the date of last signature by the Parties (Term), unless terminated earlier by the Parties as provided here in after. Upon expiry of the Term, the Parties may renew the Term of the agreement for such further period as mutually agreed to in writing by the Parties.



2.2 TERMINATION

The Dr.N.G.P.ASC and Moon Foods shall be entitled to terminate this agreement by providing a written notice of two months to other, without assigning any reasons whatsoever.

3. STUDENTS SAFETY

The Dr.N.G.P.ASC shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the Moon Foods or of maintaining discipline in the Moon Foods. The students shall strictly adhere to all the policies laid down by Moon Foods

4. REPRESENTATIONS AND WARRANTIES OF THE Dr.N.G.P.ASC

4.1 The Dr.N.G.P.ASC shall ensure that its students follow all rules and regulation of Moon Foods pertaining to leave, discipline, Practical classes, Training and Project work schedule, Grooming and Etiquettes etc. More than two incidents of indiscipline / non-cooperation will lead to intimation by Moon Foods to the Dr.N.G.P.ASC for the termination of Practical classes, Training and project work period of any students without any notice or prior information.

4.2 The Dr.N.G.P.ASC shall ensure that the students adhere to the attendance requirements as decided by Moon Foods and Dr.N.G.P.ASC during the Practical, Theory classes and Training.

5. MISCELLANEOUS

5.1 Severability: Each and every obligation under this agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.



5.2 Counterparts: This agreement shall be executed in two counterparts, all of which shall constitute one and the same agreement.
