Memorandum of Understanding

This **Memorandum of Understanding** is intended to promote cooperation between Dr NGP Arts and Science College (Autonomous), Coimbatore (Herein after referred to as Dr NGPASC), UGC approved, accredited by the NAAC with 'A⁺⁺' Grade in the Third cycle, ranked no. 75 in NIRF 25, affiliated under the Bharathiar University, Coimbatore represented by its Principal Dr. S. SARAVANAN, here in after referred to as the FIRST PARTY OF ONE PART

Nandha Arts and Science College (Autonomous), Erode (Herein after referred to as NASC), UGC approved, accredited by the NAAC with 'B⁺' Grade in the Second cycle, affiliated under the Bharathiar University, Coimbatore, represented by its Principal Dr. S. MANOHARAN, herein after referred to as the SECOND PARTY OF OTHER PART.

NOW, THEREFORE, in consideration of the mutual covenants and promises herein, the PARTIES agree as follows:

Clause 1. Objectives

- 1.1 To collaborate in providing innovative courses, student and faculty exchange programs, training, and research opportunities at DrNGPASC and NASC.
- 1.2 To jointly organize seminars and workshops.
- 1.3 To collaborate in conducting outreach programs in the community.
- 1.4 To promote joint publications of articles and collaborative projects for funding.
- 1.5 To enhance the academic quality through mutual participation.

Clause 2. Implementation

- 2.1.1 The PARTIES agree to form an Implementation Committee comprising the following members:
 - i) Principal, Dr. N.G.P. Arts and Science College (Autonomous), Coimbatore.
 - ii) Principal, Nandha Arts and Science College (Autonomous), Erode.

Clause 3. General Provisions

- 3.1 Based on the requirements, the Implementation Committee shall, in consultation with faculty and professionals, decide on the programs, events, and modes of cooperation during the term of this collaboration.
- 3.2 The institution organizing an event shall bear the responsibility for mobilizing resources and conducting such events.

- 3.3 Each PARTY shall bear the respective costs of fulfilling its obligations under this MoU. Neither PARTY shall make a claim against the other for any expenditure unless such expenditure has been agreed upon in writing between the PARTIES.
- 3.4 Any dispute or difference arising between the PARTIES shall be resolved by mutual agreement. Disagreements at the operational level shall be escalated to higher officials for appropriate resolution.
- 3.5 Nothing in this MoU is intended to affect any other cooperation or collaboration between the PARTIES.

Clause 4. Tenure and Termination

- 4.1 This MoU shall become effective from 20 February 2025 upon the signatures of the authorized representatives of the PARTIES and shall remain valid for three years. It may be amended by mutual written agreement and may be terminated at any time by either PARTY upon giving one month's written notice to the other PARTY.
- 4.2 All joint activities that are in progress at the time of expiration or termination of this MoU may continue until their completion under the terms of this MoU.

Clause 5. Amendments

- 5.1 This MoU represents the entire understanding between the PARTIES and supersedes all prior agreements, whether oral or written, with respect to the subject matter of this MoU.
- 5.2 No amendment or modification of this MoU shall be valid unless made in writing by both PARTIES and explicitly stated as an amendment to this MoU. Such modifications/changes shall become part of this MoU and shall be effective from the date on which they are executed, unless otherwise agreed.

Clause 6. Assignment

- 6.1 This MoU is based on the professional competence and expertise of each PARTY.
- 6.2 Therefore, neither PARTY shall transfer or assign this agreement, or any rights or obligations arising hereunder, in whole or in part, to any third party.

This MoU has been executed in two original copies, with one retained by NASC and the other by Dr.NGPASC. IN WITNESS WHEREOF, the PARTIES have executed this MoU and represent that they approve, accept, and agree to the terms contained herein.
