The Memorandum of Understanding (hereafter it's called as MoU) is made on 22nd April 2021 at Coimbatore, Tamil Nadu, India.

By and Between

The Dr.N.G.P. Arts and Science College (DrNGPASC),Dr.N.G.P. Nagar, Kalapatti Road, Coimbatore – 641048, represented by its Principal Prof. Dr. V. Rajendran (hereinafter referred to as **"First party"**, the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

And

Park Global HR Services of Coimbatore- 641 014, Tamil Nadu, represented by its **Mr. Sriram** (hereinafter referred to as **"Second Party"**) the institutions which expression unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns.

First Party and Second Party shall be hereinafter collectively referred to as **"Parties"** and individually has a **"Party"**.

The first party, i.e., **Dr. N.G.P. Arts and Science college** is an organization of KMCRET trust which was established in the year 1997 under the leadership of Dr. Nalla G. Palaniswami, as its Chairman and Dr.Thavamani D. Palanisami as its Managing Trustee and Secretary. The college has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was reaccredited by NAAC with “A” Grade (2nd Cycle).

The Second party, i.e., **Park Global HR Services** which was established in the year 2017 under the leadership Mr. Sriram at Coimbatore. This institution is providing services for content preparation projects for students practice, best performer will be attached to the companies as Content Writer.

Purpose

The purpose of this Memorandum is to provide the frame work for any future binding contract regarding the Certificate Course on Dot Net Technologies.

Obligations of the Parties

The Parties acknowledge that no contractual relationship is created between them by this Memorandum, but agree to work together in true spirit of Partieship to ensure that there is a united, visible and responsible leadership of the Project and to demonstrate financial, administrative managerial commitment to the project by means of the following individual services.

The activities and services for the project shall include,

- a. Services to be rendered by Dr. N.G.P. include:
Providing the Students, required infrastructure for conducting the classes
- b. Services to be rendered by Park Global HR Services include:
Providing adequate study materials, Training the Students and sending the feedback to the students.

Term

This agreement shall be valid for the period of one year from the date of last signature by the parties. Upon expiry of the term, the parties may renew the term of the agreement for such further period as mutually agreed to in writing by the parties.

Amendment

This Memorandum may be amended or supplemented in writing, if the writing is designed by the party obligated under this memorandum.

Understanding

It is mutually agreed upon and understood by and among the Parties of this Memorandum that:



- a. Park Global HR Services agrees to conduct the training for 35 hours online classes and support the students to take up any short Content preparation project as project.
- b. Dr.N.G.P. agrees to pay Rs. 1500/- Per students in two instalments. First instalment of Rs. 750/- at the begging of the training and the second instalment of Rs. 750/- at the end of the online training.

Termination

DRNGPASC and Park Global HR Services shall be entitled to terminate this agreement byproviding a return notice of two months to other, without assigning any reasons whatsoever. **Signatories**

This agreement shall be signed on behalf of **Dr. N.G.P. ARTS AND SCIENCE COLLEGE** by the Principal and on behalf of **Park Global HR Services** by **Mr. Sriram** this agreement shall be effective from the above-mentioned date.
