MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter it's called as "MOU") is made on Wednesday 12th July 2023 at Coimbatore, Tamilnadu, India.

By and Between

The Dr. N.G.P Arts and Science College (Dr. N.G.P. ASC.), Dr. N.G.P. Nagar, Kalapatti Road, Coimbatore-642109, represented by its Principal Prof. Dr. S. Saravanan (hereinafter referred to as "First Party", the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

And

The Priyadarishini Chemicals 49/2, Guru Building, Nava India Road, Near SNR Sons College, K R Puram Coimbatore – 641006, Tamilnadu, India represented by its Proprietor Lion Mr. E. Muthuchamy (hereinafter referred to as "Second Party", Coimbatore based concern).

First Party and second party shall be hereinafter collectively referred to as “Parties” and individually as a “Party”.

The first party, i.e., Dr. N.G.P. Arts and Science College (Dr. N.G.P. ASC.) is an organization of KMCRET trust which was established in the year 1997. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-Accredited by NAAC with "A" Grade (3rd Cycle).

The second party, i.e., The Priyadarishini Chemicals is an organization of which was established in the year 1997.

WHEREAS:

- A. Priyadarishini Chemicals** has agreed to assist Dr. N.G.P. ASC with respect to use of its institute to provide support to B. Sc. Chemistry Programme conducted by Dr. NGPASC.
- B.** Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering support at the **Priyadarishini Chemicals** on terms and conditions as set out in this Agreement.

NOW, THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. SCOPE OF THIS AGREEMENT

- 1.1** To permit the Students of the B. Sc. Chemistry programme conducted by Dr. N.G.P. ASC to utilize the infrastructural and instrumentation facilities available at **Priyadarishini Chemicals, Coimbatore.**
- 1.2** To conduct regular theory and practical classes at **Priyadarishini Chemicals** for the students admitted to B.Sc. Chemistry course at Dr. N.G.P. ASC.
- 1.3** To organize workshops/ Seminars/Hands-on training for the benefit of Dr. N.G.P. ASC staff and students.
- 1.4** Dr. N.G.P. ASC agreed to pay Rs.1534 (Including GST) per participant in favor of **Priyadarishini Chemicals** through cheque in end of the classes.

2. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:

2.1 TERM:

This Agreement shall be valid for a period of One (1) year from the date of last signature by the Parties (“Term”), unless terminated earlier by the Parties as provided hereinafter. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.

2.2 TERMINATION:

The Dr. N.G.P. ASC and **Priyadarishini Chemicals** shall be entitled to terminate this Agreement by providing a written notice of two months to other, without assigning any reasons whatsoever.

1. STUDENTS SAFETY:

The Dr. N.G.P. ASC shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the **Priyadarishini Chemicals** or of maintaining discipline in the **Priyadarishini Chemicals**. The students shall strictly adhere to all the policies laid down by **Priyadarishini Chemicals**.

4. REPRESENTATIONS AND WARRANTIES OF THE Dr.N.G.P.ASC:

4.1 The Dr. N.G.P. ASC shall ensure that its students follow all rules and regulation of **Priyadarishini Chemicals** pertaining to leave, discipline, Practical classes, Training and project work schedule, grooming and etiquettes etc. More than two incidents of indiscipline/ non-cooperation will lead to intimation by **Priyadarishini Chemicals** to the Dr. N.G.P. ASC for the termination of Practical classes, Training and project work period of any students without any notice or prior information.

4.2 The Dr. NGPASC shall ensure that the students to adhere to the attendance requirements as decided by **Priyadarishini Chemicals** and Dr. N.G.P. ASC during the Practical, Theory classes and Training.



5. MISCELLANEOUS:

5.1 **Severability:** Each and every obligation under this Agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.


5.2 **Counterparts:** This Agreement shall be executed in two counterparts, all of which shall constitute one and the same agreement.

5.3 **Financial Commitment:** There is no financial impediment for the both parties.
