MEMORANDUM OF UNDERSTANDING

First Party and second party shall be hereinafter collectively referred to as "**Parties**" and individually as a "**Party**".

The first party, i.e., Dr.N.G.P. Arts and Science College (DrNGPASC) is an organization of KMCRET trust which was established in the year 1997 under the leadership of **Dr.Nalla G. Palaniswami**, as its Chairman and **Dr.Thavamani D. Palaniswami** as its Managing Trustee and Secretary. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was Accredited by NAAC with "A" Grade (2nd Cycle).

The second party, i.e., Rajam Enterprises is an organization which collects and recycle the dry waste paper, which is vital element in the protection of environment operated by **Mr.S.Manuel**.

SCOPE OF THE AGREEMENT:

This MOU is intended to create a synergic alliance between **Dr.N.G.P Arts and Science College** and **Rajam Enterprises**, Coimbatore for recycling the dry waste used answer scripts, covers, card boards (if any), magazines, shredded papers, old office records etc.

1. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:

TERM:


- This Agreement shall be valid for a period of **one year** from the date of signature by the Parties ("Term"), unless terminated earlier by the Parties as provided hereinafter. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.
- **Waste Paper:** Discarded paper including all used answer scripts, covers, card boards (if any), magazines, shredded papers, old office records etc.
- **Quality and Quantity:**
- Material should be free from food particles, without any contamination of garbage, municipal waste or any item which are detrimental.
- **Minimum required Quantity:**
- Minimum required quantity is 200 Kgs

TERMINATION:


- The DrNGPASC and Rajam Enterprises shall be entitled to terminate this Agreement by providing a written notice of 2 months to other, without assigning any reasons whatsoever.

2. ROLES AND RESPONSIBILITIES OF DrNGPASC:

- DrNGPASC shall identify the quantum of wastepaper at various locations in the campus
- DrNGPASC would store the used answer scripts, covers, card boards (if any), magazines, shredded papers, old office records etc., and shall inform to Rajam Enterprises to pickup on mutually agreed schedule
- DrNGPASC agrees to appoint The Principal / Nominee as the representative to coordinate on various activities as in MoU and notify Rajam Enterprises within one month of any change in the responsibility

- DrNGPASC shall issue a sale invoice in the name of Rajam Enterprises with local applicable rates and GST to enable faster payment from Rajam Enterprises Invoice shall be sent by post / courier to the address given in the MoU within two days from the date of collection of material with the copies weighment slip
- Payment will be processed immediately on the date of receipt of the invoice along with gate pass and weighment slip

3. ROLES AND RESPONSIBILITIES OF RAJAM ENTERPRISES

- Rajam Enterprises shall submit the prevailing rates from time to time and get approval from DrNGPASC
- In considerations for enabling Rajam Enterprises to pick up the materials from DrNGPASC, Rajam Enterprises shall pay to DrNGPASC, the consideration amount based on weight recorded
- Rajam Enterprises will make arrangements for collecting and transporting the waste paper on its own along with own employees
- Rajam Enterprises shall weigh and load the stationery in front of the authorised person from DrNGPASC
- Rajam Enterprises shall sweep and clean the record room after removing the stationery
- Examination papers taken from DrNGPASC will be used for recycling purpose also. Such examinations papers will not go for reuse and any un authorised hands which may lead to misuse of dissemination of confidential information
- Rajam Enterprises shall not use or disseminate any confidential information printed on the waste paper, if the waste paper which is not properly shredded by DrNGPASC
- Rajam Enterprises shall issue the pulping certificate issued from paper mill if the stationery is sent to pulping
- If any default in the execution of the above work Rajam Enterprises, Coimbatore will take up the whole responsibility.

4. MISCELLANEOUS:

- ✓ **Severability:** Each and every obligation under this Agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.
- ✓ **Relationship:** The relationship between Parties is that of an independent contractor and neither Party hereto is an agent or partner of the other Party for any purpose whatsoever.
- ✓ **Assignment:** Neither Party shall assign this Agreement or its rights and obligation hereunder without the prior written consent of the other Party.
