## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter it's called as "MOU") is made on **Thursday 18<sup>th</sup> March 2021 at Coimbatore, Tamilnadu, India.**

### By and Between

The **Dr. N.G.P Arts and Science College (Dr. NGPASC)**, Dr. N.G.P. Nagar, Kalapatti Road, Coimbatore-642 109, represented by its Principal Prof. Dr. V. Rajendran (hereinafter referred to as "**First Party**"), the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

### And

The **Veljo Tailoring and Embroidery training Center**, Aunthoniyar nagar, somanur Coimbatore-641668, represented by its Founder Ms.V.Subathra (hereinafter referred to as "**Second Party**", Coimbatore based concern).

First Party and second party shall be hereinafter collectively referred to as "**Parties**" and individually as a "**Party**".

**The first party, i.e., Dr. N.G.P. Arts and Science College (DrNGPASC)** is an organization of KMCRET trust which was established in the year 1997. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-Accredited by NAAC with "A" Grade (2<sup>nd</sup> Cycle).

**The second party, i.e., The Veljo Tailoring and Embroidery training Center is an**

**WHEREAS:**

- A. Veljo Tailoring and Embroidery Training Center has agreed to assist Dr. NGPASC with respect to use of its institute to provide support to B. Sc. Costume Design and Fashion Programme conducted by Dr. NGPASC.
- B. Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering support at the Veljo Tailoring and Embroidery Training Center on terms and conditions as set out in this Agreement.

**NOW, THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

**1. SCOPE OF THIS AGREEMENT**

**1.1. Purpose:**

The purpose of the memorandum of understanding is to ensure and offer certificate/value added training for students, placement and Development co-operation between Dr. NGP Arts and Science College and Veljo Tailoring and Embroidery Training Center, Coimbatore which provides instrumentation facilities.

**1.2. Training and Development:**

- To conduct regular theory and practical classes at Veljo Tailoring and Embroidery Training Center for the students admitted to B.Sc. Costume Design and Fashion course at Dr.N.G.P. Arts and Science College.
- To organize workshops/ Seminars/Hands-on training for the benefit of Dr. N.G.P. ASC staff and students.
- Training period will be 50hrs. The charges for the training will be mutually decided by both the parties.

**1.3 Fee Structure:**

Course Fee & Schedule of Payment

(i) The agreed course fee per student is Rs.1300/- (exclusive of GST)

(ii) Schedule of Payment.

- (a) First 50% of the fee will be paid after completion of the 25hrs of classes.
- (b) Balance 40% of the fees will be paid after completion of the remaining 25hrs of classes.
- (c) Final 10% of the fees will be after completion of the following:
  - (i) Conducting of the requisite Exams
  - (ii) Declaration of relevant results.
  - (iii) Handling over the requisite course completion certificate to the students as mentioned in 'Purpose clause 1.1 through the respective HoD of the Department as mentioned in "Purpose clause 1.1 in respect of party of the Second part.
  - (iv) Certificate jointly signed by the principal as mentioned in "Purpose clause 1.1 in respect of party of the Second part authorizes signatory of the party of the First part confirming the points as mentioned.

2. **TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:**

**2.1 TERM:**

This Agreement shall be valid for a period of Two (2) years from the date of last signature by the Parties ("Term"), unless terminated earlier by the Parties as provided hereinafter. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.

**2.2 TERMINATION:**

The Dr. NGPASC and Veljo Tailoring and Embroidery Training Center shall be entitled to terminate this Agreement by providing a written notice of two months to other, without assigning any reasons whatsoever.

3. **STUDENTS SAFETY:**

The Dr. NGPASC shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the Veljo Tailoring and Embroidery Training Center of maintaining discipline in the Veljo Tailoring and Embroidery Training Center. The students shall strictly adhere to all the policies laid down by Veljo Tailoring.

4. **REPRESENTATIONS AND WARRANTIES OF THE Dr. NGPASC:**

4.1 The Dr. NGPASC shall ensure that its students follow all rules and regulation of Veljo Tailoring and Embroidery Training Center pertaining to leave, discipline, Practical classes, Training and project work schedule, grooming and etiquettes etc. More than two incidents of indiscipline/ non-cooperation will lead to intimation by Veljo Tailoring and Embroidery Training Center to the Dr. NGPASC for the termination of Practical classes, Training and project work period of any students without any notice or prior information.

4.2 The Dr. NGPASC shall ensure that the students to adhere to the attendance requirements as decided by Veljo Tailoring and Embroidery Training Center and Dr. NGPASC during the Practical, Theory classes and Training.



5. **MISCELLANEOUS:**

5.1 **Severability:** Each and every obligation under this Agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.


5.2 **Counterparts:** This Agreement shall be executed in two counterparts, all of which shall constitute one and the same agreement.
