The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-Accredited by NAAC with A++ Grade (3<sup>rd</sup> Cycle-3.64 CGPA).

The second party, i.e., Analytics Society of India situated at B-206, Indian Institute of Management Bangalore, Bannerghatta Road, Bangalore -560076 is a not-for-profit membership driven, professional association, and strives to help individuals become more valuable through education, community, research, and advocacy.

#### WHEREAS:

- A. The Analytics Society of India has agreed to provide classes/courses/programs for the interested students of Dr.N.G.P.Arts and Science College, Coimbatore.
- B. Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering VAC hands on training classes for the Information Visualization Course on terms and conditions as set out in this MoU.

# NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

#### 1. CLAUSE 1 & 2: COOPERATION & SCOPE OF THIS AGREEMENT

- 1.1 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of Second Party in providing Information Visualization Course through hands-on training mode and believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 1.2 Curriculum Design: Second Party will give valuable inputs as per the schedule allotted by the First Party in teaching methodology and suitably customize the curriculum.
- 1.3 Coaching Classes: Second Party will coach the students through qualified Skill
- 1.4 **Tests:** The students will be given test and assessed at the end of the course. Practical assignments are also to be submitted at the end by students.

#### **CLAUSE 3- INTELLECTUAL PROPERTY**

#### **CLAUSE 4- VALIDITY**

This agreement is valid for a period of one year from the date of signing of this agreement by both the parties. Either party can terminate this agreement in written communication by providing 60-day notice period. During the notice period it is agreed that both the parties will work towards a smooth transition, clear any pending deliveries for that particular period, clear pending dues if any.

#### Services:

We share the common vision of empowering the students by imparting skill sets and increasing their employability.

To achieve our common goal, Dr.N.G.P.Arts and Science College and Analytics Society of India would collaborate on the following framework to execute the students' skill training.

#### Role of Analytics Society of India

- To provide training classes for the committed number of students. (In this case 120 students)
- 2. To provide qualified faculty for hand-on training.
- 3. To complete the full syllabus within the prescribed time along with exercises and assignments
- 4. To maintain the attendance records of the students and intimate the same to the college.

#### **Payment Terms**

The course fee for the Value-Added Course, Certification in Information Visualization is Rs. Rs. 3815 /- which includes Rs. 1750 (Trainer cost Subject to TDS payable to Ms. Sharada Sringeswara) and Rs.1750 (Subject to GST and TDS payable to Analytics Society of India) per student.

#### Roles of Dr.N.G.P Arts and Science College

- 1. The schedule and details of training to be shared with Analytics Society of India
- To provide required arrangements and coordination for conducting classes through offline mode.
- 3. To provide frequent monitoring on students attendance.
- 4. To allow students regularly to attend the training classes as per the schedule and recommend the students to attend exercises and assignments.
- To appoint student in charges for each batch to coordinate exam and evaluation of assignments.
- 6. To provide 30% of the fee for students joining the course as advance and pay the balance 70% amount after the course.
- 7. The institution reserves the rights to cancel the MoU if it is dissatisfied with the training.

# Each Party represents and warrants to the other as follows:
