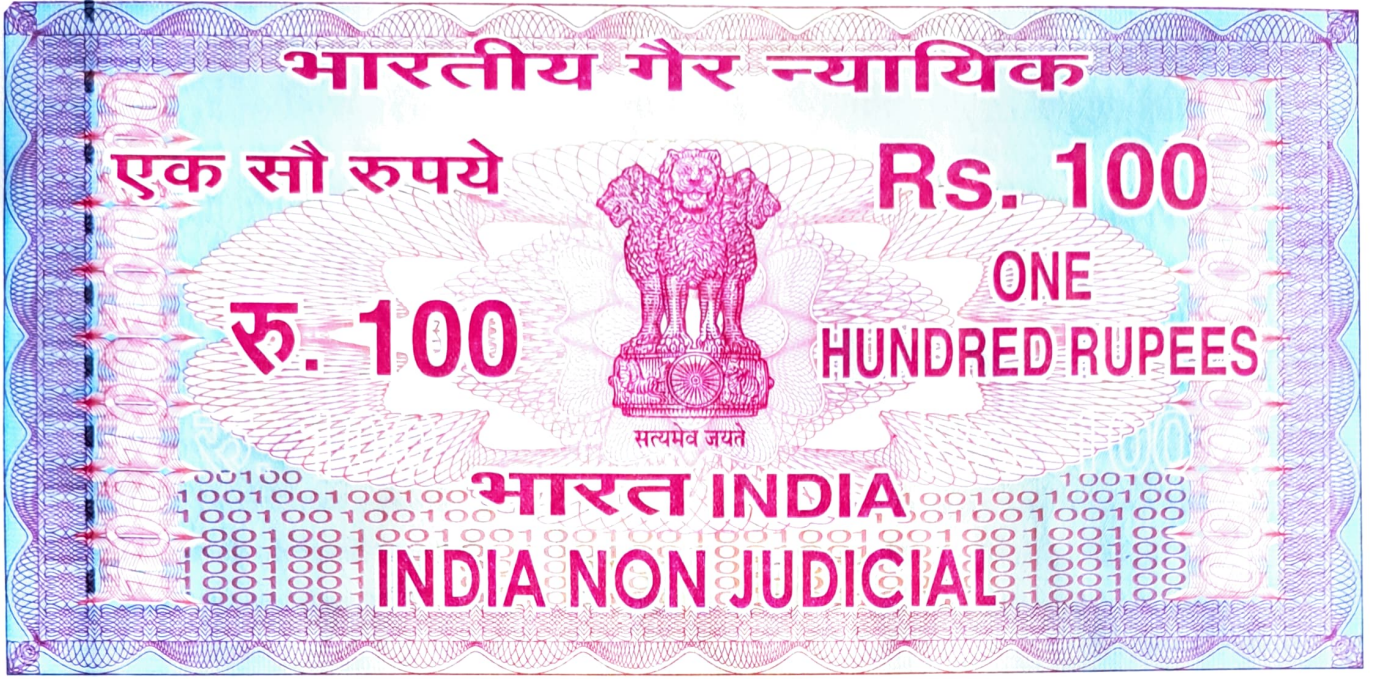

WHEREAS:

Arts and Science College**, the First Party is a co-educational self-financing autonomous institution, affiliated to Bharathiar University, Coimbatore, Tamil Nadu. offering undergraduate, postgraduate & doctoral programmes in Arts, Science and Management. The institution is recognized under 2(f) & 12(B) and conferred autonomous status during the academic year 2015-16 by University Grants Commission, New Delhi and is accredited with A++ Grade (3rd Cycle) by NAAC. Eight science departments are recognized under DBT-STAR Scheme.

7. The Parties are desirous of entering into this Memorandum of Understanding (hereinafter be referred to as “MoU”) to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

THE PARTIES HAVE REACHED AN UNDERSTANDING ON THE FOLLOWING MATTERS

1. OBJECTIVE

2. AREAS OF COOPERATION

- 2.1) Joint education and research activities related to industry-relevant projects.
- 2.2) Organization of joint industry-academic workshops and seminars to bridge the gap between academia and industry practices.
- 2.3) Exchange of personnel for internships, project work, and hands-on training experiences.
- 2.4) Exchange of training materials, project documentation, and technical publications.
- 2.5) Support for internship and Placement

3. EFFECT OF THIS MEMORANDUM OF UNDERSTANDING

This MoU is not intended to be legally binding but it simply expresses the intentions and understanding between both Parties. The Parties may enter into a legally binding Memorandum of Agreement while incorporating terms from this MoU.

4. NO AGENCY

The relationship between the Parties will be non-exclusive in nature. The MoU does not prevent a Party from entering into arrangements with other third parties. Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or to make either Party the agent of the other

5. ENTRY INTO EFFECT AND DURATION

5.1) This MoU shall become effective from the date of signing by both Parties herein.

5.2) This MoU will remain in effect for a period of five (5) years.

5.3) This MoU may be extended for such further period as agreed in writing by both Parties.

6. REVISION, VARIATION AND AMENDMENT

6.1) Either Party may request in writing a revision, variation or amendment of this MoU.

6.2) Any such revision, variation or amendment agreed to by the Parties in any clause of the MoU shall be mutually agreed by both the parties.

6.3) Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.

6.4) Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or based on this MoU before or up to the date of such revision, variation or amendment.

7. TERMINATION

This MoU may be terminated by either Party with a minimum of THIRTY (30) days written notice from one Party to the other. Activities in progress at the time of termination of this MoU shall be permitted to conclude as planned unless otherwise agreed.

8. NOTICES

Any communication between the Parties under this MoU shall be in writing in the English language and delivered by registered mail to the postal address or sent to the electronic mail address as stated herein, be deemed to be duly given or made when delivered to the recipient at such postal address or electronic mail address.

Resolution of Disputes:

- Each Party shall comply in all respects with all applicable legal requirements governing its respective duties, obligations, and business practices of that Party and shall obtain necessary permits or licenses for its operations. Neither Party shall take any action in violation of any applicable legal requirement that could result in liability being imposed on the other Party.
