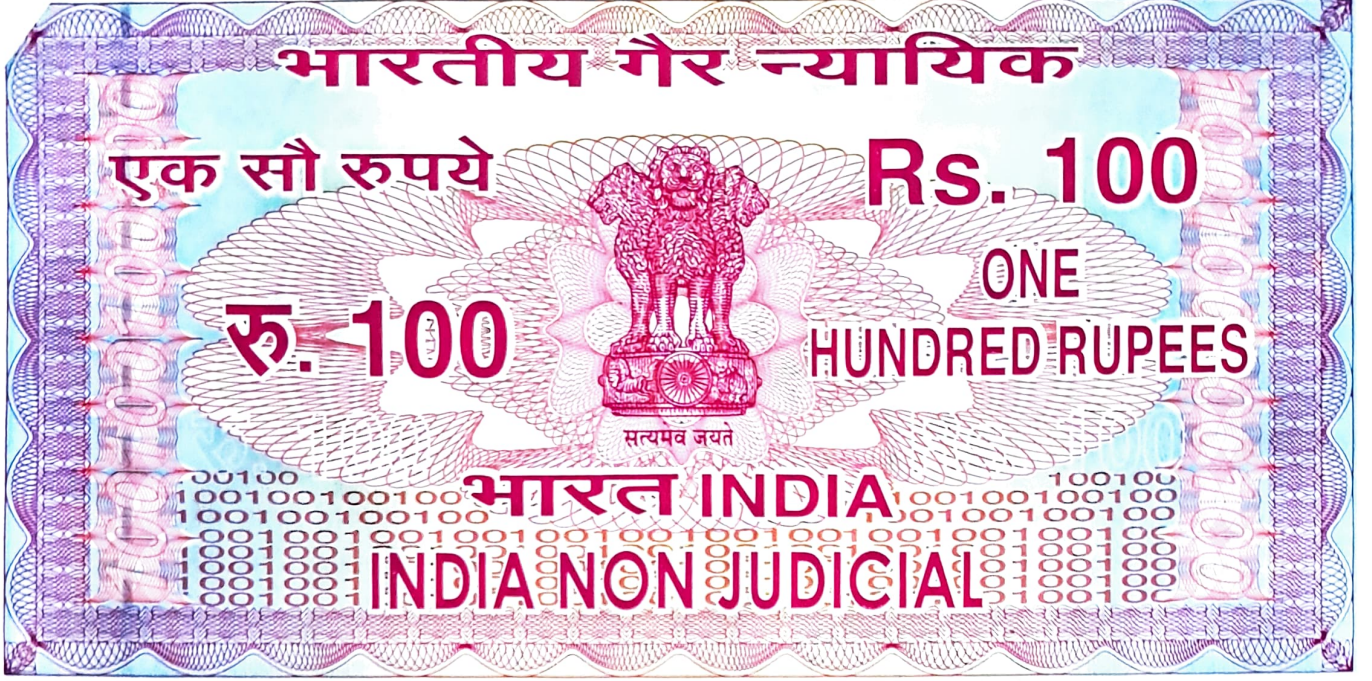

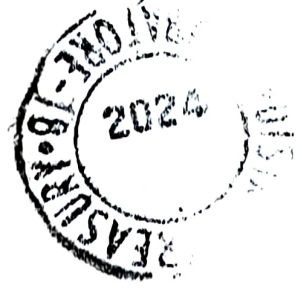

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (here after it's called as "MOU") is made on 10.01.2025 at Coimbatore, Tamil Nadu, India.

By and Between

The **Dr. N. G. P. Arts and Science College (Dr. NGPASC)**, Dr. N. G. P. Nagar, Kalapatti Road, Coimbatore - 641 048, represented by its **Principal Prof. Dr. S. Saravanan** (here in after referred to as "**First Party**"), the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

And

The **LITZ Tech, Coimbatore** represented by **Mr. Levale Xavier**, Director - Business Development, Coimbatore region coordinator (hereinafter referred to as "**Second Party**"), the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

First Party and second party shall be here in after collectively referred to as “Parties” and individually as a “Party”.

The first party, i.e., **Dr. N. G. P. Arts and Science College (Dr. NGPASC)** is an organization of Dr. N.G.P. trust, which was established in the year 1997. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re- Accredited by NAAC with "A++" Grade (3rd Cycle).

The second party, i.e., LITZ Tech has expanded its services to include upskilling and student skill development, boasting a network of over 200+ Customers and employees, along with a student base of over 10,000 who have benefited from our upskilling platform. Specializing in IT technologies, we offer placement services in partner organizations worldwide, a commitment we've upheld since our establishment in 2011.

WHEREAS:

- A.** LITZ Tech has agreed to assist Dr. NGPASC with respect to use of its institute to provide support to **Mathematics Department** Programme conducted by **Dr. NGPASC**.
- B.** Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering support at the **LITZ Tech** on terms and conditions as set out in this agreement.

NOW, THIS AGREEMENT WITNESSETH AND IT IS HERE BY AGREED BY AND BETWEEN THE PARTIES HERE TO AS FOLLOWS:

1. SCOPE OF THIS AGREEMENT

1.1 Purpose:

- The purpose of the memorandum of understanding is to ensure and offer Certificate / Value Added Training for Students, Placement and Development co-operation between **Dr. N.G.P. Arts and Science College** and **LITZ Tech**, Coimbatore and share the knowledge and skills available in both organizations.

1.2 Training & Development:

- To organize Guest lecture, Value Added Program, Faculty Development Program, Workshops, Seminars, Internship, Project Hands-on training for the benefit of **Dr. NGPASC** staff and students.



1.3 Exchange of Information and Documents:

- **Dr. N.G.P. Arts and Science College** and **LITZ Tech**, Coimbatore shall arrange for the exchange of information and documents concerning matters of common interest.

1.4 Technical Co-operation

- Whenever desirable, **Dr. N.G.P. Arts and Science College** and **LITZ Tech**, Coimbatore may seek each other's technical co-operation with a view to promoting the development of Collaborative activities in field of common interest.

1.5. Amendments

Both parties may request the present Memorandum of Understanding beam ended. Any such amendments shall be adopted by mutual consent. Whenever required an exchange of letters will detail the implementation of the article.

2. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:

2.1 Term: This Agreement shall be valid for a **period of three (3)** years from the date of last signature by the Parties ("Term"), unless terminated earlier by the Parties as provided here in after. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.

2.2 Termination: The **Dr. NGPASC** and **LITZ Tech** shall be entitled to terminate this Agreement by providing a written notice of three months to other, without assigning any reasons whatsoever.

2.3 Financial Commitment: The cost of the programme will be decided based upon the number of students joining the Courses and mutually Agreeable by both the parties.

3. STUDENTS SAFETY:

The **Dr. NGPASC** shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the **LITZ Tech** or of maintaining discipline in the **LITZ Tech**. The students shall strictly adhere to all the policies laid down by **LITZ Tech Limited**.

4. REPRESENTATIONS AND WARRANTIES OF THE Dr NGPASC:

4.1 The **Dr. NGPASC** shall ensure that its students follow all rules and regulation of Hack up Technology pertaining to leave, discipline, Practical classes, Training and project work schedule, grooming and etiquettes etc.



More than two incidents of indiscipline/ non-cooperation will lead to intimation by **LITZ Tech** to the Dr. NGPASC for the termination of Practical classes, Training and project work period of any students without any notice or prior information.

4.2 The Dr. NGPASC shall ensure that the students to adhere to the attendance requirements as decided by **LITZ Tech** and Dr. NGPASC during the Practical, Theory classes and Training.

5. MISCELLANEOUS:


5.1 **Severability:** Each and every obligation under this Agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.

5.2 **Counterparts:** This Agreement shall be executed in two counterparts, all of which shall constitute one and the same agreement.
