


I. Responsibilities/Deliverables from the College side:

- Shall coordinate with Makeintern and facilitate conduct of all the assessments.
- Shall share the details of students in a prescribed format to ensure that there is no duplication of beneficiaries.
- College need to inform Makeintern well inadvance for any of the training requirements and shall decide the schedule mutually.
- Shall be responsible for hospitality arrangements of the Trainer/Resource Person

II. Responsibilities/Deliverables from the Makeintern:

- Makeintern will conduct Training in the college on the Topic Selected by the College in online/offline mode as agreed mutually.
- Makeintern will select 5 Students from a Batch of _____Students who would be visiting IIM Calcutta Campus for the Business Plan Championship Program
- Makeintern will also look after the accommodation arrangements of selected students and for one faculty accompanying the students (Some Nominal Charges would be there)
- Makeintern will provide the Adequate Trainer/Faculty for the training Commencement on the dates decided mutually by the college and Makeintern.
- Makeintern will provide marketing Material (Posters/Banner) to promote the Training Program in campus.
- Makeintern will also assist the college in internships for all the participants (Given the adequate time and information at least a month prior to the requirement)
- Makeintern will provide their LMS Access to all participants for the revision of course.

Timeline: This agreement shall commence from July, 2024 till July, 2025 unless this Agreement is terminated pursuant to the provisions hereof.


Consideration: The deliverables agreed here under the agreement shall be considered the sufficient consideration from each party for this Agreement; being yearlong association having no barter/kind consideration.

VII. Applicable Law

This Agreement shall be governed by the laws of India. Any dispute arising out of this Agreement shall be adjudicated through Arbitration by a sole Arbitrator appointed by **Dr.N.G.P. Arts and Science College, Coimbatore** or Makeintern's Director. Such arbitration shall be governed by
