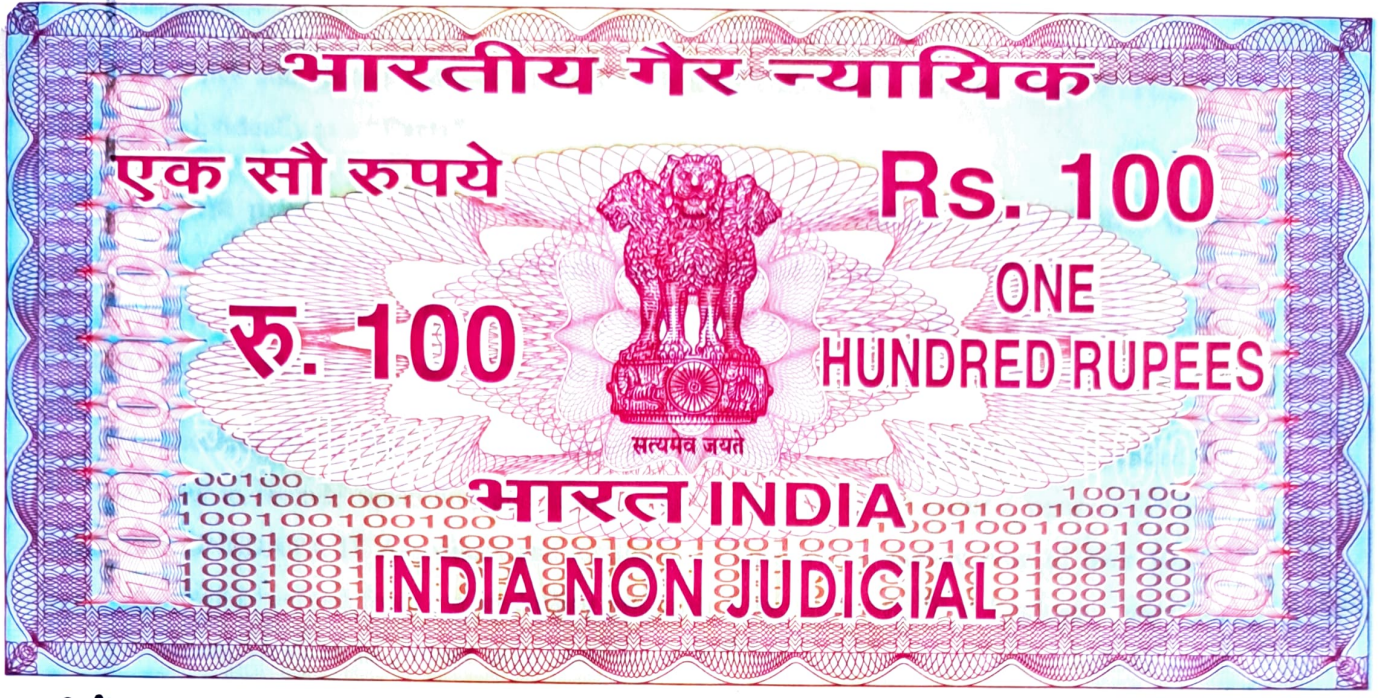

## 1.3 Exchange of Information and Documents:

## 1.4 Technical Co-operation

- Whenever desirable, **Dr.N.G.P. Arts and Science College and OneData Software Solutions Private Limited**, Coimbatore may seek each other's technical co-operation with a view to promoting the development of Collaborative activities in field of common interest.

## 1.5. Amendments

Both parties may request the present Memorandum of Understanding beam ended. Any such amendments shall be adopted by mutual consent. Whenever required anexchange of letters will detail the implementation of the article.

## 2. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:

**2.1 TERM:** This Agreement shall be valid for a **period of three (3) years** from the date of last signature by the Parties ("Term"), unless terminated earlier by the Parties as provided here in after. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.

**2.2 TERMINATION:** The **Dr.NGPASC and OneData Software Solutions Private Limited** shall be entitled to terminate this Agreement by providing a written notice of three months to other, without assigning any reasons whatsoever.

**2.3 Financial Commitment:** The cost of the programme will be decided based upon the number of students joining the Courses and mutually Agreeable by both the parties.



### 3. STUDENTS SAFETY:

The **Dr.NGPASC** shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the **OneData Software Solutions Private Limited** or of maintaining discipline in the **OneData Software Solutions Private Limited**. 
