First Party and Second Party shall be hereinafter collectively referred to as "Parties" and individually as a "Party".

Arts and Science College (Dr. N.G.P.ASC) is an organization of KMCRET trust which was established in the year 1997 under the leadership of Dr. Nalla G Palaniswami, as its Chairman and Dr.Thavamani D Palaniswami as its Managing Trustee and Secretary. The second party, i.e., **TOPMANS EDUCATION AND CAREER HORIZONS PVT.** LTD. situated @ Angamaly, Kerala is an established Academic Institution offering students, Skill Development Course in GST.

WHEREAS:

- A. The TOPMANS EDUCATION AND CAREER HORIZONS PVT. LTD has agreed to provide GST classes for the interested students of Dr. N.G.P. Arts and Science College, Coimbatore.
- B. Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering coaching classes for the GST Course on terms and conditions as set out in this MoU.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:



1. SCOPE OF THIS AGREEMENT

CLAUSE 4 - VALIDITY

This agreement is valid for a period of one year from the date of signing of this agreement by both the parties and shall automatically renew for successive one-year terms unless terminated by either party upon at least 60 days' written notice prior to the end of the thencurrent term. Either party can terminate this agreement in written communication by providing 60-day notice period. During the notice period it is agreed that both the parties will work towards a smooth transition, clear any pending deliveries for that particular period, clear pending dues if any.

- 1. To co-operate fully with the other, and with the other's employees, agents and contractors, with a view to facilitating and enhancing the Parties performance of their respective obligations hereunder;
- 2. Not to use, publish or disclose any information or material produced or supplies by the other Party hereunder, without the other Party's prior written consent, for any purposes other than those contemplated under this Agreement; and
- 3. To promptly inform the other Party of any claims or complaints of which the informing Party becomes aware relating to the other Party or its activities in connection with its performance under this Agreement.



Entire Agreement:


