Program 1: Corporate Quiz [*Biz Whiz Quiz*]

1. Team Composition:

- Each team must consist of two members only.
- Team members must be students of the same institution.

2. Preliminary Round:

- **Format:** Written test with 50 questions.
- **Duration:** 45 minutes.
- **Open to:** Any number of teams from one college.
- **Scoring:** One point for each correct answer. No negative marking for incorrect answers.
- **Qualifying:** The top 4 teams with the highest scores advance to the final round.
- **Tie-breaker:** In the event of a tie in the results, a tie-breaker round will be conducted with additional questions.

3. Final Round (On-Stage):

- **Format:** Multiple rounds with varying question genres.
- **Rounds:** The Quiz Master will explain the format of each round before it begins.
- **Direct Questions:**
 - Teams will have 30 seconds to answer direct questions.
 - Correct answers will be awarded 10 points.
 - Incorrect answers will result in no points.
- **Passed Questions:**
 - If a team is unable to answer a question, they can pass it to another team.
 - If the receiving team answers correctly, they will be awarded 5 points.
 - If the receiving team answers incorrectly, no points will be awarded to any team.
- **Quiz Master's Decision:** The Quiz Master's decision on all matters relating to the quiz is final and binding.

4. General Rules:

- **Fair Play:** Teams are expected to compete in the spirit of fair play. Any form of cheating or unethical behaviour will result in disqualification.
- **Mobile Phones:** The use of mobile phones or any other electronic devices is strictly prohibited during the preliminary and final round of quiz.
- **Audience Participation:** Audience members are requested to remain quiet during the quiz and refrain from assisting the teams.

Program 2: Paper Presentation [*Ideas Xchange*]

Topics for Ideas Xchange:

1. Impact of ESG investments on Business Profitability;
2. Role of Board Room diversity and Professional Management in inclusive growth;
3. Artificial Intelligence Machine Learning – challenges and opportunities;

4. Corporate Social Responsibility: driving change or maintaining status quo
5. Secretes of sustainable startups in the era of AI and ML (sustainability is in the context of sustenance of business model)

Rules of Ideas Xchange

1. An article on any one of the above 1 – 5 topics in MS Word format containing not more than 1200 words along with PPT of the article must be sent to our chapter email icsicorpquest@gmail.com on or before 25.12.2024.
2. Entries received after the due date given in point no. 3, will not be accepted by the organisers;
3. No limit on number of participants per college;
4. A team can consist of one or maximum two participants;
5. While sending the article to the mail id, the student(s) has to mention the following details in the same order on top of the article:
 - a. Full name of the student:
 - b. Student registration number as per student identity card of the college:
 - c. Registration number given by organisers after the registration Corp Quest 2025:
6. The article and PPT will be evaluated by our panels of judges and articles selected by them will be invited for presentation on the stage.
7. Time allotted for presentation will be strictly 5 – 7 for each finalists
8. The participant should bring their PPT and presentation paper in pen drive on the event day
9. Plagiarism be avoided
10. Legible copy of the college Identity card of the student(s) to be mailed along with the article and PPT.

Rules for Reel Impact

1. Student(s) must send their short films in MP4 format on or before 25.12.2024 to the mail id icsicorpquest@gmail.com;
2. While sending the short film to the mail id, the student(s) has to mention the following details in the same order on top of the mail:
 - a. Full name of the student:
 - b. Student registration number as per student identity card of the college:
 - c. Registration number given by organisers after the registration Corp Quest 2025:
3. No limit on number of participants per college ;
4. A team should have one or maximum two participant ;

5. The short films will be screened by our panel of judges and best five will be displayed on stage during the program;
6. Best three will be chosen by judges on stage;
7. Duration of short film can be 5 to 7 minutes, and not more than 7 minutes.

1. Mock Board Meeting
2. Mock AGM

Rules of Program 4

1. Each participating college can send only one team for any one of the topics;
2. The team can consist of minimum 5 & maximum 10 people;
3. The college can choose any one of the two topics and train their team;
4. Best three teams will be chosen on the day of the event;
5. The team which comes first will be given a chance to perform their mock event on stage based on the time availability;
6. The winner will be college as a whole;
7. The duration of the mock meeting cannot be more than 10 to 15 minutes;

General Terms and Conditions:

1. Attractive prizes and cups will be given to all winners;
2. College Identification card is must for all the students and the legible copy of the student identity card has to be given by the student while making registration via google form.
3. On the day of the program, each participant has to possess his/ her college identity card;
4. Student includes both UG and PG student;
5. Organisers reserve the right to change the rules of any event either before or on the day of the event according to the necessity;
6. Participation certificate will be given to all those students who have taken part in any of the four events;
7. Registration fee amount has to be transferred to the bank account of the chapter or by scanning the QR code given in the google form;
8. After payment of the fee either online or scanning QR code, the UTR code has to be sent to the mail id icsicorpquest@gmail.com or be mentioned in the google form.
9. For the Programs 2 to 4, there will be two judges for each event, who will be members of the ICSI;
10. Two judges will rank the winners according to the well-defined criteria set by the organisers;
11. The judges decision will be final for each event;
12. Out station students have to take care of their travel arrangements.
